

#### Rules and regulations of accommodation in student halls of residence

§1

The Rules and regulations of accommodation in student halls of residence, hereinafter referred to as the "Regulations," apply to all participants of EUG 2022 residing in student halls of residence.

§2

#### Rights and obligations

- 1. EUG 2022 participants may stay in the room on the day of official arrival from 4:00 p.m. and must check out at the latest by 10.00 a.m. one day after the end of the competition of the discipline in which they are participating.
- 2. During check-out, the group manager will check the status of the vacated rooms together with the person from the EUG 2022 Organising Committee.
- 3. EUG 2022 participants have the right to enter and exit the building at any time upon presentation of a proof of identity document (ID).
- 4. Quiet hours are observed in the student halls of residence between: 11:00 p.m. 6:00 a.m.
- 5. The doors to the student halls of residence are locked during the quiet hours. During this time, only EUG 2022 participants accommodated in the facility, persons authorised by the EUG 2022 Organising Committee, as well as other persons may be allowed into the premises, after prior approval from the EUG 2022 Organising Committee.
- 6. Keys/access cards to student rooms/hall of residence will be issued at check-in by receptionists and volunteers.
- 7. EUG 2022 participants are responsible for the issued keys/access cards.
- 8. For losing a key or access card to a particular student hall of residence, the Organising Committee imposes a penalty of €60. Payment will be charged using the terminal, in PLN at the current exchange rate of the National Bank of Poland.
- 9. Persons who are not residents of the student halls of residence and who are in a state indicating the misuse of alcohol or drugs are not admitted to the student halls.
- 10. The EUG 2022 Organising Committee or the Coordinating Volunteer has the right to decide to remove non-residents from the premises of the student hall who disturb the peace of the residents by their behaviour. This decision is enforced by the security staff of the student hall/academic estate or the intervention patrol.

- 11. The EUG 2022 Organising Committee, the coordinating volunteer and persons authorised by the EUG 2022 Organising Committee shall have the right in justified cases (repair, disinfection, disinfestation) to enter the rooms at any time.
- 12. EUG 2022 participants are required to keep the rooms and common areas clean and tidy.
- 13. When checking out of the student halls of residence, participants must leave the room intact and in the same condition as on the day the room was issued.
- 14. A report will be made of any damage to the room, lost or damaged towels, bed linen or other equipment.
- 15. Failure to return towels, bed linen or damage thereto as well as damage to or loss of other room furnishings will be fined by the Organising Committee in accordance with the price list for the relevant range. The Lodz University of Technology will also claim reimbursement for loss/destruction from the participant. Price list shown in the table below:

Destruction of walls and other property will be valued in the replacement cost estimate.

- 16. The group supervisor/manager is responsible for checking the rooms before departure and, in case of any damage or deficiency, report this to the representative of the Organising Committee. The participant responsible for the destruction is obliged to pay a fee for the damage caused. In case of concealment of damage, the university referring the participant to the Games will be informed of the above-mentioned fact.
- 17. The Participant is obliged to pay for the damage caused in a cashless form to the representative of the Organising Committee at the accreditation office for those accommodated in student halls of residence belonging to Lodz University of Technology and to the representative of the Organising Committee supervising student halls of residence of the University of Łódź who is on duty on the campus of the University of Łódź. The participant will receive confirmation of payment in accordance with Appendix No. 1.
- 18. For each unfounded call to the uniformed services, the perpetrator of the false report will be held liable for the costs of carrying out the action. The Organizing Committee shall not be held responsible for such events.
- 19. EUG 2022 participants have the right to use the allocated room and the general premises of the student hall, as well as facilities intended for shared use.
- 20. EUG 2022 participants have the right to use their own equipment brought into the room (e.g. audiovisual equipment, computer equipment, radio equipment, etc.) with the proviso that the EUG 2022 Organising Committee is not materially responsible for this equipment (damage, theft).
- 21. Participants in the EUG 2022 are obliged to respect the property of the student residence and to prevent its misuse.
- 22. EUG 2022 participants are required to report noticed failures, damage and equipment faults to coordinating volunteers.

## Use of laundry services

- 1. Participants of EUG 2022 can use commercial laundry points located in student hall of residence No. 5 on the Campus of the University of Lodz and in the student house No. 4 on the Campus of Lodz University of Technology.
- 2. Participants shall pay for laundry services by card or in cash; in the case of payment in cash, payment only in Polish zloty (PLN).
- 3. Each of the points will operate from Monday to Sunday, from 08:00 a.m. to 11:00 a.m., 3.00 p.m. 6.00 p.m.
- 4. The price list for individual elements of the outfit is presented in the laundry points.

**§4** 

### Rules for changing towels and throwing away rubbish

- 1. Replacing towels and disposing of rubbish will take place according to the specified schedule located on the door of each room.
- 2. During the absence of the participant in the room, towels will be replaced and rubbish removed only if a key is left to the room at the reception desk of the student hall of residence.
- 3. The service will be held from 8:00 a.m. to 11:00 a.m.
- 4. After the service, keys/cards will be available for collection at the reception upon presentation of an identification document.

§5

In the buildings of student halls of residence it is forbidden to:

- 1. Conduct, use and distribute narcotics, cigarettes and alcohol.
- 2. Share room keys/cards to third parties.
- 3. Make your place in the student residence available to third parties.
- 4. Remove towels and bed linen and other equipment from the student residence premises.
- 5. Change the accommodation without consulting the Organising Committee or the volunteer coordinating the accommodation.
- 6. Smoke, drink alcohol, use other psychoactive stimulants and use open flames, and store flammable materials.
- 7. Put the lives and health of your and your fellow residents at risk.

**§6** 

#### Transitional and final provisions

- 1. The Regulations shall enter into force on 1 July 2022.
- 2. Residents' disputes regarding residency in student halls of residence are considered by the EUG 2022 Organising Committee.
- 3. In matters not covered by these Rules and Regulations, decisions shall be taken by the Organising Committee of EUG 2022.
- 4. The EUG 2022 Organising Committee is the appeal body for all matters covered by the Regulations.

5.	The Accommodation rules and regulations must be signed by all EUG 2022 participants accommodated in student houses and delivered to the accreditation office during accreditation of participants.
